

TRANSPARENCY CODE 2015

The Local Government Transparency Code 2015 (the Code) came into effect on 1 April 2015. The code is issued by the Secretary of State for Communities and Local Government in exercise of powers under section 2 of the Local Government, Planning and Land Act 1980. The Code replaces any previous codes issued in relation to authorities in England under those powers. When a local authority has gross annual income or expenditure which exceeds £200,000 in a financial year (1st April – 31st March) it is required to provide certain information which includes contracts that have exceeded £5000. For the financial year 2024-2025 the Parish Council's gross expenditure exceeded £200,000 and the contract information is listed below.
