#### 7/24 To receive an update on Council accounts:

The Clerk informed Members of the changes to the Council's accounts and the transfers of funds between accounts including notice given to close one account. Members **RESOLVED** to also give notice to transfer funds of £40000.00 from the Nationwide account to the Council's current account.
